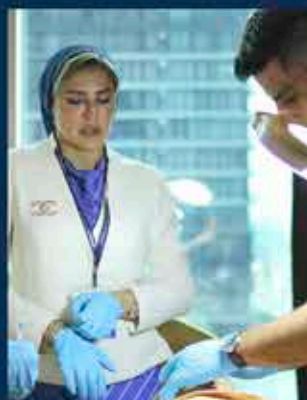

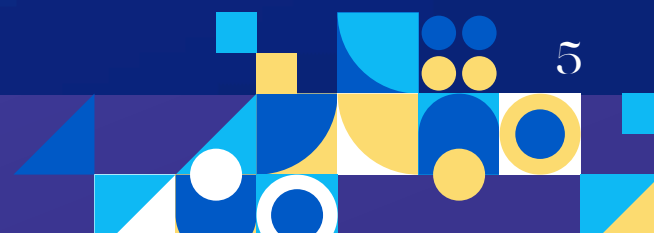

WELCOME MESSAGE

Ever since the days of Cleopatra of ancient Egypt, of Helen of Troy and of Imperial Concubine Yang Gui Fei of ancient China, beauticians and beauty knowhow has been one of the oldest professions in the world.

Ever since there has been human illness and sickness, there too is the age-old practice of medicine- also another very old and noble profession.

It is awesome and amazing that these two of the oldest professions are converging in form and substance to become aesthetic medicine or AM in short.

Everyone at this Las Vegas congress knows that AM or aesthetic medicine is the use of evidence-based minimally invasive medical procedures, therapeutics and consumables in clinical settings to improve and augment human beauty.

Everyone here is aware that no single doctor or person can be said to have started or founded the AM sector.

Aesthetic medicine came about because there was and still is the need to apply a body of evidence based medical knowhow to human beauty and several decades ago, it all came together quite spontaneously and powerfully and its momentum that took off in the 1970s in Europe became an unstoppable global phenomenon.

The American Academy of Aesthetic Medicine (the AAAM in short) is one of the very early and pioneering organizations in aesthetic medicine training as it was formed in the 1990s.

Today, even as artificial intelligence changes the world, as many people work from home and the online world grows much faster than the real world, aesthetic medicine is one of the few rare sectors that continues to grow rapidly in the real world. There are now hundreds of thousands of AM doctors, millions of consumers and revenue in the billions.

Expanding in leaps and bounds, aesthetic medicine cannot go away. Aesthetic medicine will become even more part and parcel of everyday life in the years to come.

Today, more and more doctors are setting up practices in aesthetic medicine. The supply and the competition are growing. Fortunately, the demand from consumers too is strongly growing.

For every one of you here, there is a future that is rewarding and satisfying in the practice of aesthetic medicine but aesthetic medicine doctors and practitioners have to bear in mind several key observations if they are to stay successful!

I like to share some of these observations as we start the AAAM congress this year in Las Vegas.

My first observation is that it's so easy to forget that the consumer, as your patient, do not see or regard the aesthetic medicine doctor in the same way as patients who are sick and ill who seek the healthcare services role provided by the traditional family doctor or medical specialist!

In aesthetic medicine, the consumer who is your patient pays from her or his own pocket and can be very demanding, even unreasonable at times. Some consumers may have dangerously unrealistic expectations of results. Never forget that your patient, as a fussy consumer, is ever ready to switch to another aesthetic medicine clinic. To make matters difficult, consumers may often be misled or misinformed by irresponsible social media or digital advertisements.

We must all take care that the very first consultation by a consumer with an aesthetic medicine doctor is often not even the beginning of the patient-to- doctor relationship. We must not forget that the consumer sitting before you may not yet made up her or his mind to become your patient. The person may still be window shopping! Never ever make such a common mistake or else your patient may be your worst enemy if you are not careful.

Aesthetic medicine doctors should be very careful about the need and the process to get a sufficient written patient consent which is far more than that needed if you are a family doctor!

The American Academy of Aesthetic Medicine, or triple A M in short is planning to compile case studies or instances of how aesthetic medicine doctors have had bad experiences with unrealistic unreasonable consumer patients. AAAM would update you in later conferences, congresses or publications. AAAM is coining the term "consumer -patients" to highlight the key difference with conventional patients of traditional family doctors and medical specialists!

A second observation is that Public Health care authorities and health ministries all over the world are generally keeping a wary eye over the rapid growth of aesthetic medicine and its impact on the public healthcare system, in particular of the brain drain of doctors into the AM or aesthetic medicine sector. It follows that Public medical universities as well as practice licensing rules, for the same reasons, are not exactly rushing ahead to embrace or support aesthetic medicine subjects and education.

It's only to be expected that the formal recognition of aesthetic medicine in the way that other traditional medical sub specialties have had long become formally recognized and conferred remains slow and lags behind for aesthetic medicine.

As an AM doctor, each of you need to be mindful that your own national healthcare regulator is watching the aesthetic medicine sector with a somewhat wary eye which you must not forget that aesthetic medicine is seen by governments as an elective luxury and not as a basic health necessity. In fact, the cold reality during the COVID pandemic, was that many nations ordered aesthetic medicine clinics to be closed as they are regarded as non-essential health services.

Given such wary perceptions and caution by many public health authorities and regulators in the world, it is key that aesthetic medicine doctors do not bring bad publicity into the sector. This implies each and every aesthetic medicine doctor need to be careful and to engage only in responsible advertising, that is, to exercise reasonable professional restraint and not go overboard with irresponsible marketing or promotion.

My third observation is that the regulation of the aesthetic medicine sector varies all over the world. There is a very wide range from minimal regulation to light self-regulation and a few nations with rigid regulations.

Everyone of you would have to stay updated on your own nation's regulations. As and when more of you are kept updated, there is better likelihood to learn from other nations so that in your own host nation you can then propose or suggest for changes as may be needed.

Another key observation is that innovation is incessant in the aesthetic medicine sector. The growth potential has attracted more suppliers and manufacturers.

To keep pace with innovation, every aesthetic medicine doctor has to keep up to date on the latest as well as on his professional responsibilities.

Innovation is rapid in new injectables and new consumables. A new fast-growing innovation is in regenerative medical injectables and consumables.

Technology innovation is also into med tech energy systems - from lasers to RF, to ultrasound cryogenic tech.

With innovation comes Scientific reports and papers. The challenge for every one of you is to sieve through - to get to the actual objective evidence of these innovations- separating from the usual commercially often self- serving narratives of suppliers and manufacturers.

To help you to see the difference, AAAM plans to introduce and focus even more on the objective evidence as differentiated as reasonably possible from too excessively commercial narratives.

A closing observation is that aesthetic medicine is no longer the exclusive domain of any single nation or a small group of advanced western nations. Strong momentum is building up in other parts of the world. Korea and parts of Latin America for example are notable and upcoming.

In conclusion, Aesthetic medicine has no differences across nations, it cuts across races, gender, age and culture. Beauty for everyone, for all colors of skin, from the young to the old, is the new reality.

Every practitioner in aesthetic medicine has to take a global view and not simply his or her own nation. Attending a congress such as this by AAAM in Las Vegas is invaluable.

In fact, meeting with your peers and learning from each other is the fastest and most effective way for professional development. Not every innovation or new procedure can become reported or embedded into an AM publication or paper. The very essence of AM excellence which is the core of AAAM has always been peer learning and peer teaching. A congress such as the one you attending now is a valuable form for sharing by peers and learning peer to peer.

On behalf of The American Academy of Aesthetic Medicine, I trust that all delegates, Americans and international participants alike would have an enjoyable and beneficial engagement at this Congress. Thank you!

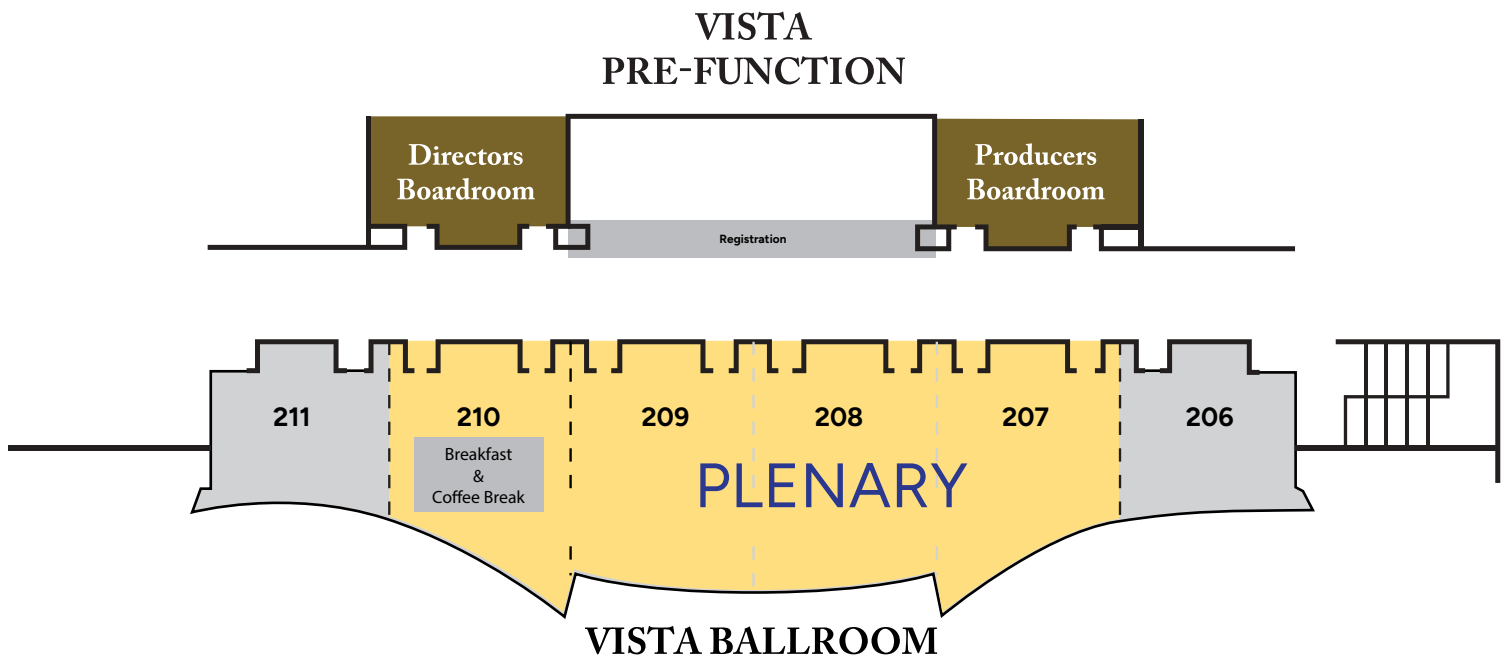

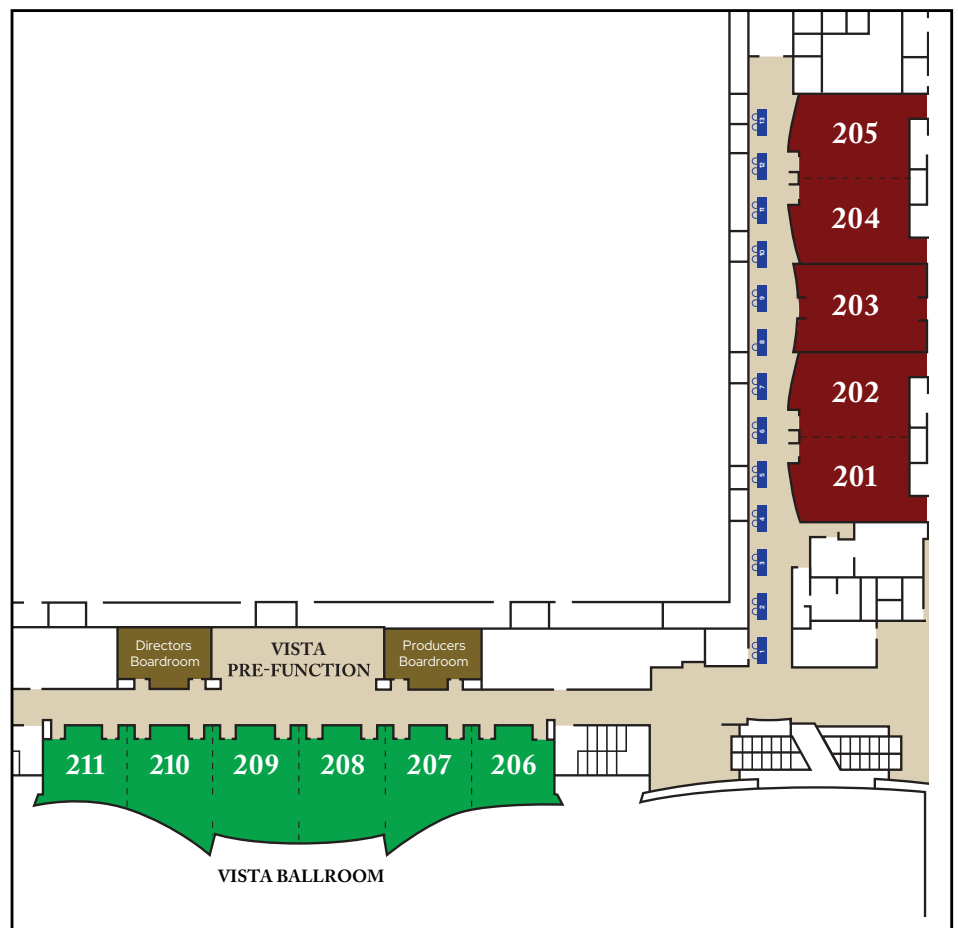
FLOORPLAN OVERVIEW
